**Saturday, Day 1**  
**October 18**

**Arrival in Nairobi**

After collecting your luggage and clearing customs, you will be met by a Me to We Trip staff member at the arrival gate.

**Check into Karen Blixen Coffee Garden**

Built in 1908, this house was the home of the coffee farm manager for the Blixen Coffee Plantation. The home has been fully restored to its original historic glory and now serves as a luxurious resort for guests. A full English breakfast is served in the resort's lush gardens.

**Sunday, Day 2**  
**October 19**

**Nairobi**

Our first day in Nairobi is about acclimatization and building our community. Highlights include: Full buffet breakfast at Karen Blixen, opening gathering of our group, lunch in the garden at the Karen Blixen, a visit to The Giraffe Center and the David Sheldrick Elephant Orphanage. These are special opportunities and our group will have close encounters with the animals. We'll end our day with a welcome dinner at Karen Blixen.

**Monday, Day 3**  
**October 20**

**Depart from Wilson Airport to Maasai Mara**

Fly by private charter from Nairobi to the Maasai Mara.

Highlights include: Flight over the Maasai Mara and our first walk together on African land. You'll be greeted with traditional song, and settle into your new African home. You'll meet the Bogani staff, and get oriented to your new home and learn about local communities. As you drift off to sleep in your luxury cottage or tent, you might hear howling hyenas or the rumbling of a nearby elephant herd.



**Mon – Fri, Day 4 - 8**  
**Oct. 20 - 24**

We will work in earnest to build our special community. Highlights include: Volunteer service in nearby villages, meetings with traditional elders and women leaders, visits to the Mara river and local schools to experience daily life and a one-on-one walk with a Maasai warrior on their ancestral land. Local and traditional activities will be blended with David & Kathy's unique facilitation and community sharing to be woven throughout your time.

**Sat & Sun Day 9-10**  
**Oct. 25 & 26**

**Depart from Bogani for to the Fairmont Mara Safari Club**  
Surrounded on three sides by the Mara River, the Fairmont is the epitome of tented luxury. With four-poster, pillow-top beds and a veranda overlooking the hippo and crocodile-filled river, each tent is superbly furnished. The location is home to an astounding array of animals including zebras, cheetahs, wildebeests, gazelles and of course the "Big Five". Highlights include: Morning and evening drives to look for giraffes, lions, elephants, hippos and buffalos! Each day promises extraordinary wildlife opportunities and our nights by a campfire will be spent toasting our good fortune and sharing our stories. Weather permitting participants can opt for a sunrise balloon ride over the Maasai Mara (not included).

**Depart for Vipingo From Wilson Airport**

Fly by charter plane to Vipingo and make your way to the beautiful Kenyan coast.



### **Check-in to Toriana Guesthouse**

Settle into your new home positioned on a four acre plot overlooking a long white sandy beach. This Spanish-style villa provides a quiet, quaint setting on the stunning Bofa Beach.

This remote area has managed to stay unspoiled and untouched by the mass tourism and development that has hit much of Kenya's coastline. The beach is protected by a coral reef which allows for safe, and calm swimming conditions. The hot subtropical day is very pleasant by the crystal clear turquoise water of the Indian Ocean. Activities include visiting the ancient town of Kilifi, snorkeling, fishing, bird watching, walking the unspoiled beach or just plain relaxing!

One of the best attractions in Kilifi is a visit to the ancient Mnarani ruins and its fascinating tombs with mosques dating back to the 14th century.

### **RESERVATION AND TRAVEL POLICIES**

1. **HOW TO BOOK** – You and any minor(s) for whom you sign on the last page of this form (collectively, the “**Participant**”) must fill out the attached reservation form and return it, together with a deposit payment to the Company at Me To We Trips, 225 Carlton Street, Toronto, Ontario M5A 2L2. On receipt of your signed reservation form and payment the Company will, subject to availability, reserve you a place on your trip.

2. **CANCELLATION BY PARTICIPANT** – Upon receipt of your signed reservation form, a deposit of \$1,000 USD will be required. In the event of a cancellation outside of the 90 days until your scheduled trip, a full refund will be given minus a \$1,000 administrative fee. In the event of a cancellation within 90 days of your scheduled trip, 100% of the costs will be forfeited.

3. **CANCELLATION BY THE COMPANY** - The Company reserves the right to cancel the Kenya Trip at any time due to insufficient subscription. In addition, the Company may, at its sole discretion and without liability, at any time, cancel or terminate a Participant's booking and, without limiting the generality of the foregoing, if the Company does so as a result of illness or illegal or inappropriate behaviour of the Participant, the Participant shall not be entitled to any refund. The Company's relationship and reputation with the communities Participants visit is integral to the Company's business and the Participant must at all times behave in an appropriate and respectful manner. If a Participant acts or behaves in a way that the Company deems to be inappropriate or disrespectful, the Company reserves



the right to terminate the Participant's participation in the Kenya Trip at the Participant's expense and such Participant shall not be entitled to any refund.

4. **RESPONSIBILITY FOR COSTS** - The person making this booking warrants that he or she has authority to enter into a contract on behalf of any and all of the persons included in such booking and, in the event any or all of the persons so included fails to make payment in respect thereof, the person making this booking agrees to assume personal liability for the total price of the booking.

5. **SCHEDULING CHANGES** - Although every effort is made to adhere to schedules provided, the Company reserves the right at any time prior to or during the Kenya Trip to cancel the Kenya Trip or any portion thereof or to make any alteration in travel route, accommodation and/or any other trip details as the Company may, in its sole discretion, deem necessary as a result of changing conditions or for any other reason whatsoever. Any extra expenses incurred as a result of the Kenya Trip or any part thereof being rendered impossible, illegal or inadvisable because of an "Act of God", weather, strike or other disruption, war, political instability, interference or terrorism or for any other reason whatsoever shall be the sole responsibility of the Participant. The Participant acknowledges that he or she will rely solely on his or her private travel insurance covering such matters for financial remuneration.

6. **PRICES** - The Company will use its best efforts to operate the Kenya Trip based on the price quoted to the Participant. However, should increased costs be incurred as a result of changes in airline prices and other third party costs, exchange rates, etc., the Company reserves the right to charge the Participant a corresponding surcharge.

7. **REFUNDS** - While the Company agrees to use its best efforts to ensure that all accommodation and excursions are available as planned, a Participant shall be entitled to make no claim of any nature whatsoever against the Company for a refund, either in whole or part, if any accommodation or excursion is unavailable or if the Participant is unable to engage in any event or excursion, or otherwise use a service.

8. **MEDICAL PRECAUTIONS** - Participants must be healthy before embarking on the Kenya Trip. A physical examination by a doctor is highly recommended to determine that the Participant is healthy enough to travel and to partake in the physically demanding nature of the excursion. Medical prescriptions may not be refillable during the Kenya Trip. It is advisable that the Participant bring a sufficient amount of all necessary medication. A certificate from a medical doctor is highly recommended if the Participant will be bringing any form of prescription drugs, syringes or other medical paraphernalia into a developing country. If the Participant wears contacts or glasses, he or she must bring a spare pair along on the Kenya Trip. Also, a pair of good quality UV-protective sunglasses is essential and should be regularly worn along with sunscreen and a hat. Travel health depends largely on pre-departure preparations, daily attention and the handling of problems as they arise. Participants are exposed to different environmental factors, foods and sanitation standards, but following a doctor's advice and using common sense will help minimize risks. It is very important to note that the list of vaccinations given below is by no means meant to replace professional medical advice. The Participant must discuss travel health matters with his or her doctor. It is strongly recommended that the Participant seek out a "travel doctor" who specializes in these matters. The most commonly recommended vaccines for travel to Africa are yellow fever, typhoid, tetanus, polio, Hepatitis A and B and meningitis. Me To We Trips facilitators, for example, have received all of these shots and it is strongly recommended that Participants speak to their doctor about these vaccines. Other



vaccines may be required or recommended by your doctor. Plan ahead for vaccinations. A time lapse may be required if an initial shot requires a booster. Some vaccinations should not be given together. **It is recommended that Participants begin receiving vaccinations a minimum of six weeks prior to travel.** All vaccines should be recorded in an International Health Certificate, which is available from one's doctor or health department. Proof of yellow fever inoculations on your international health card is required when visiting Kenya. Many of the places we travel to have potential malaria zones. Malaria is a disease transmitted by mosquitoes and can be fatal. There are currently no vaccinations against malaria, but anti-malarial drugs significantly reduce the risk of becoming ill or dying from malaria. These drugs do not prevent infection, but they can kill the malarial parasite during a certain stage in their development. It is highly advised that all Participants take the appropriate anti-malarial medication, which often has to be taken before and after the Kenya Trip. Certain areas of the world in which malaria exists are considered to be chloroquine-resistant. It is recommended that the Participant consult the Center for Disease Control and a travel doctor to find out if they may be exposed to malaria zones during the Kenya Trip.

9. **PASSPORT AND VISA** - The Participant must have a passport issued by his or her country of citizenship which is valid for **at least six months** after the conclusion of the Kenya Trip. For Participants traveling on passports issued by countries from outside of North America, Kenya may require you to have a visa to gain entry. **It is the responsibility of the Participant to obtain visa(s) for the country or countries to which the Participant is traveling with Me To We Trips.** While at times visas may be obtained at the port of entry, it is the responsibility of the Participant to determine if this applies to the country or countries to which the Participant is traveling. The Participant may also need to obtain transit visas for any countries that he or she is traveling through to get to their final destination. It is the responsibility of the Participant to contact the relevant embassies or consulates in order to obtain this information. Me To We Trips accepts no responsibility and will issue no refunds for money already paid in the event of Participants not obtaining a visa in time or having a visa application refused. The Participant is advised to keep photocopies of valuable documents, such as passports, visas, traveler's check receipts, travel insurance policies, personal contacts and addresses, credit card numbers, airline tickets and birth certificates. When copying a passport, the Participant should be sure to copy pages with his or her name, passport number and photo, the place and date of issue and the expiry date. It is advisable to keep photocopies of important documents separate from one's passport and money. The Participant should keep one copy with him or her, one copy inside his or her luggage and one copy with a Me To We Trips facilitator. Copies of these documents should also be left with someone at home.

10. **CRIME** - There may be no readily accessible embassy or consulate in the places visited. Embassies or consulates may not provide much assistance in an emergency situation if the situation is in any way the result of a Participant's actions. Participants must remember that the laws of the country that they are visiting are binding on them. The national embassy will not be sympathetic if a Participant is imprisoned after committing a crime locally, even if the activity in question is legal in one's home country. In genuine emergencies, one may be able to get some embassy assistance, but only if other channels have been exhausted. Please consult the US State Department and/or the Foreign Affairs and International Trade Canada website, which provide advice and information for travelers. Travel advisories change from time to time and should therefore be regularly consulted. Crime rates vary by country and by region. Participants should never presume that they are in a "safe" zone. Participants should not flash jewelry, money or any other valuables while in public areas. Participants are not permitted to bring valuables and expensive jewelry on the trip.



11. **SAFETY TIPS** - Participants are advised to keep money, passports, air tickets, etc. safe from pickpockets. Participants are reminded that the best place to keep their valuables is out of sight under one's clothes or in a money belt. It is suggested that Participants do not keep all of their money and important documents in one place. Keep small change and a few banknotes in a shirt or pant pocket to pay for small expenses without having to extract large amounts of cash. Me To We Trips assumes no responsibility or liability for any loss or theft of Participants' personal items while on a trip organized by Me To We Trips.

12. **FEMALE TRAVELERS** - Modest dress and composure is essential and expected of female travelers in all locations. Short sleeves are generally fine; however, hemlines should not be much above knee-level and sleeveless shirts or tank tops are generally unacceptable. To avoid unwanted attention, prevent sunstroke and keep cool, it is best to cover up as much as possible. Regardless of their attire, female travelers may be exposed to verbal harassment from local men and boys.

13. **INSURANCE** - It is mandatory that all Participants purchase individual travel and medical insurance as well as insurance for loss of property. Me To We Trips does not hold any of these types of insurance for Participants and will accept no liability for any loss of property or travel related to personal or medical emergencies. Participants may purchase travelers insurance from Me To We Trips. Participants should compare different policies to determine which provides the best coverage. When buying travelers insurance, Participants are advised to check the fine print. Some policies exclude "dangerous activities", which may include hiking, being in the proximity of wild animals, etc. Policies with such exclusions would not be appropriate as Participants may be taking part in activities deemed "dangerous" by insurance providers. Participants may prefer a policy that pays doctors or hospitals directly rather than one requiring Participants to make payments on the spot and then submit a claim for reimbursement later. Participants are advised to check the policy to ensure coverage of emergency transport evacuation to their home country. Participants are advised to obtain the maximum amount of medical, personal and travel insurance possible.

14. **DIETARY RESTRICTIONS** - Participants with special dietary requirements are advised to warn the Company well in advance of the Kenya Trip departure date.

15. **BAGGAGE** - Participants are requested to limit luggage on domestic flights to one medium-sized duffel bag weighing a maximum of 22 lbs. as domestic flights are operated by private planes.

16. **DELAYS** - The Company shall not be responsible for any delays, including any delays resulting from airlines not running according to schedule.

17. **GUIDES** - If a guide is unable to accompany a trip for any reason whatsoever, the Company reserves the right to substitute another guide.

18. **FLIGHTS** - Participants are responsible for reconfirming international flights.

19. **PERSONAL INFORMATION** - The Company is committed to collecting, using and disclosing personal information responsibly. The Company will only collect, use and disclose your personal information as necessary for the purposes of communicating with you regarding the travel products and



services that you request, as necessary for the provision such travel products and services, and for any other purpose for which your consent has been obtained at or prior to the time of use or disclosure, except where otherwise permitted or required by law. The Company may also use your personal information to provide you with our electronic updates. If you would prefer not to receive such electronic updates, you may opt out at the bottom of this form. 20. **THIRD PARTY BOOKINGS** - The Company may disclose your personal information to third party service providers assisting in the provision of travel products and services that you request (such as travel agents, airlines and local organizations in the countries visited on the Kenya Trip) or as otherwise permitted or required by law.

### **WAIVER, RELEASE, INDEMNITY AND ACCEPTANCE OF RISKS**

In consideration of the acceptance by the Company of the Participant's application and the granting of permission to participate in the Kenya Trip, the Participant confirms as follows:

1. **PHOTOGRAPHY RELEASE** - The Participant grants full permission in perpetuity to the Company and/or Free The Children to copyright, reproduce, use, reuse, license, exhibit, display, distribute and create derivative works of any photographs, slides, films, videotapes, recordings or any other content taken of the Participant in connection with the Kenya Trip or any related events whether in print, CD-ROM, videotape, electronic or other format for any purpose whatsoever (including, but not limited to, promotional materials such as informational brochures, websites, television shows and public information campaigns) without further notice and with no expectation of financial or other consideration to be paid to the Participant in connection therewith. The Participant acknowledges and accepts that such photographs, slides, films, videotapes, recordings or other content, including any appearance of the Participant included therein, may be edited at the sole discretion of Me To We and/or Free The Children.

2. **ACCEPTANCE OF RISKS** - The Participant recognizes that he or she will be engaged in various activities during the Kenya Trip that involve certain dangers and risks that cannot be eliminated regardless of the care taken to avoid injuries. Specifically, the dangers and risks include, but are not limited to:

- potential exposure to disease, including proximity to or working with people who may be suffering from illness;
- proximity to wild, poisonous, or dangerous animals;
- travel by air and land, including non-traditional means of local transportation, which may include, among others, the use of rickshaws, motorbike taxis, mules and backs of pick-up vans;
- exposure to the elements, including physically demanding hikes, walks and excursions in significant heat; and
- exposure to unknown people in public places, including large crowds.

The specific risks vary from one activity to another but in each activity, the potential consequences associated with the risks range from minor injuries to catastrophic injuries including paralysis and death.

The Participant has read the previous paragraphs and: (1) understands the nature of the activities on the Kenya Trip, (2) understands the demands of those activities relative to the physical condition of the Participant, and (3) appreciates the types of illnesses and injuries which may occur as a result of activities



made possible by the Company. By signing this Waiver, Release, Indemnity and Acceptance of Risks below, the Participant confirms and agrees that participation is voluntary and that the Participant knowingly assumes all risks associated with this participation.

3. **WAIVER AND RELEASE** – The Participant (on his or her own behalf and on behalf of his or her heirs, executors, personal representatives, and assigns) waives all claims against and releases the Company, its affiliated companies, its partners, any companies acting on its behalf, Free The Children and each of their respective directors, officers, employees, volunteers, sponsors, independent contractors, and agents (the “**Releasees**”) from liability for any and all claims, demands, damages, costs (including legal costs), expenses, actions and causes of action, whether in law or equity, that the Participant has or may in the future have against the Releasees, including claims arising from their negligence. This waiver applies to any claims against the Releasees of any kind relating to the Participant’s person or property including claims arising from (1) personal injury (including death) from accidents, injuries or illnesses arising from participation in various activities during and in connection with the Kenya Trip; and (2) damage to, or loss or theft of, property, and regardless of whether such death, injury, damage, loss or theft was caused or contributed to by the negligence of any of the Releasees.

4. **INDEMNITY** – The Participant agrees to indemnify and hold harmless the Releasees from and against any damages, interest or costs, including the full amount of all lawyers’ fees and disbursements, paid or payable by the Releasees in connection with any claim the Participant or others may bring notwithstanding this Waiver, Release, Indemnity and Acceptance of Risks.

The Participant further agrees to indemnify and hold harmless the Releasees with respect to any and all liability, costs and expenses incurred by any of the Releasees as a result of the Participant’s participation in the Kenya Trip, which includes indemnifying and holding harmless the Releasees from and against all claims and costs related to legal or other action brought against the Releasees for damages caused by the Participant.

5. **LIMITATION OF LIABILITY** - The Participant hereby acknowledges that in no event shall the maximum liability of Me To We Trips, its affiliates, employees, agents, volunteers and authorized representatives arising out of the Participant’s participation in the Kenya Trip, whether based upon contract, tort, negligence, strict liability or otherwise, exceed in the aggregate the amounts paid by the Participant to Me To We Trips to participate in the Kenya Trip, and in no event shall Me To We Trips, its affiliates, employees, agents, volunteers and authorized representatives be liable for any damages other than direct damages, even if Me To We Trips has been advised of the possibility of such damages.

6. **BINDING** - The Participant hereby confirms that this Waiver, Release, Indemnity and Acceptance of Risks shall be binding upon his or her heirs, executors, administrators and other legal representatives and their respective successors and assigns.

7. **SEVERABILITY** - This Waiver, Release, Indemnity and Acceptance of Risks is intended to be as broad and inclusive as is permitted by law. If any portion of it is held invalid, or unenforceable as against the Participant or the Participant’s parents/legal guardians (if applicable), the remaining portion(s) of the Waiver, Release, Indemnity and Acceptance of Risks will continue in full legal force and effect. To the extent any of the provisions of this Waiver, Release, Indemnity and Acceptance of Risks is deemed unenforceable by a court of competent jurisdiction or duly appointed arbitrator, such court of arbitrator



shall have the authority to modify such provisions to the extent necessary to make them enforceable, such modification to preserve as much as possible the parties' original intentions with respect to such provisions.

8. GOVERNING LAW - This Waiver, Release, Indemnity and Acceptance of Risks shall be governed by and construed in accordance with the laws of the Province of Ontario and the laws of Canada applicable in Ontario.

9. DISPUTE RESOLUTION - All disputes, disagreements, controversies, questions or claims arising out of or relating to this Waiver, Release, Indemnity and Acceptance of Risks shall be determined by arbitration under the *Arbitration Act, 1991* (Ontario) (the "**Arbitration Act**") and any hearing in the course of the arbitration shall be held in Toronto, Ontario in the English language. Subject to section 44 of the Arbitration Act, any award or determination of an arbitrator shall be final and binding on the parties and there shall be no appeal on any ground, including, for greater certainty, any appeal on a question of law, a question of fact, or a question of mixed fact and law. All matters relating to the arbitration shall be kept confidential to the full extent permitted by law and no individual shall be appointed as an arbitrator unless he or she agrees in writing to be bound by this dispute resolution provision.
